By now you may have read or heard about the news story about a member in California that was accused of serious sexual misconduct.

**We want you to know that we have immediately, today, begun expulsion procedures to remove that member, Dominic Foppoli, from the Active 20-30 U.S. & Canada organization.**

We are conducting an independent investigation. If you have information related to this or other incidents of serious sexual misconduct please contact me or the national office directly so we can put you in touch with our independent investigative team.

We acknowledge the pain and anguish of the victims of these events, as well as the enormous courage those victims demonstrate in publicly addressing their experiences. No one, whether an Active 20-30 Club member or not, should ever have to tolerate this kind of abuse. I stand with the victims of these abuses, and I am inspired by the courage of the victims in speaking out at this time.

Out of these horrible allegations, we are working to make our organization stronger and a more supportive community.

### **Official Statement**

The Active 20-30 U.S. & Canada ("Active 20-30" or the "Club") Board of Directors, myself included, recently became aware of allegations of serious sexual misconduct on the part of an Active 20-30 member, some of which occurred in connection with Club events. While we are not yet fully aware of the facts in this matter, we acknowledge the pain and anguish of the victims of these events, as well as the enormous courage those victims demonstrate in publicly addressing their experiences. No one, whether an Active 20-30 Club member or not, should ever have to tolerate this kind of abuse.

The Board of Directors is both saddened and outraged in the wake of these allegations and stands firmly with the victims. The Board of Directors deeply regrets any lapses on its part that may have permitted this abuse to persist, and the victim's suffering prolonged. The Board of Directors is taking new, concrete steps to better ensure that each and every member of the Club is protected from such abuses in the future, and that abusers and potential abusers will be rooted out of the Club expeditiously, as any abusive conduct is not tolerated in Active 20-30.

The Board of Directors pledges that abusive or potentially abusive behavior related to any Club member or Club activity will be thoroughly and zealously investigated and addressed.

On April 8, 2021 the National board initiated expulsion procedures to remove Dominic Foppoli from the Active 20-30 U.S. & Canada organization.

The Board of Directors of Active 20-30 stands by its members who have been harmed and hopes that any Club member who wishes to reach out to the Board for resources and support will do so.

I stand with the victims of these abuses, and I am inspired by the courage of the victims in speaking out at this time.
